Team Update

- Board Chair *Charles Teh* moved this agenda item up to proceed the Public Comment portion of the meeting
- Librarian Elissa Bleess provided an update on services at the Law Library
 - A new computer workstation provides self-represented litigants the opportunity to file their exhibits online.
 - o The Law Library continues to provide civil and family legal advice.

Public Comment / Introduction of Visitors:
