7.1. Team Updates – Intergenerational – Kristin Schneider

There has been an increased need for STOC (substitutes) coverage and have received an increase in that budget. There will be a shortfall in the fines and fees income line of the budget that will need to be made up elsewhere. *Foss* expressed his desire to move toward a fine-free library system.
