7.1. Budget Update – Jodi Edstrom (see IFS report enclosed)

Edstrom - No major updates with the budget. When asked about fines she stated each library's fines are listed separately, rather than one line item. Additional budget would be required to offset this income if CCL goes fine-free as is a goal. Only two MELSA libraries charge fines. Spencer reported that only 23% of Minnesota libraries charge fines, at least 57% are completely fine-free, and the others charge fines on some items.

7.2. Library Director-Jodi Edstrom (enclosed)

Summer reading is now in full swing, a busy time for staff. Chanhassen has begun construction on its civic campus which is to wrap up in 2026. Staff has attended several library conferences. MELSA has begun its executive director search. Training for the Humanity scheduling software will take place for management in June and the rest of the staff in July.
